RE: Design update meeting for “One Park” rezoning case #16ZONE1044, still from C-2 to Planned Development District (“PDD”), consisting of mixed residential, office, retail and restaurant on 3.32 +/- acres at the intersection of Lexington Road and Grinstead Drive, specifically 2294, 2300, 2338 & 2340 Lexington Road and 2501, 2503, 2509, 2511 & 2515 Grinstead Drive

Dear Neighbor:

We are writing to invite you to attend an additional and presumably final meeting with neighbors for purposes of showing everyone our updated design for the proposed “One Park” project. This meeting follows the previous 11 charrettes that we hosted on June 21, 22, 23, September 26 & 28, 2016, August 15 & 16, 2017, September 19 & 20, 2017, October 24, 2017 and June 27, 2018 with various neighborhood groups, area residents and adjoining property owners.

This update meeting to present the revised design will be held on **Tuesday, April 23rd** beginning at **7:00 pm** at the **Highland Garage** located at **2036 Midland Avenue**.

The venue for this meeting is a very interesting property, one built in 1905 as the original horse and carriage barn for the nearby Olmsted parks. It was reported that in the 1930s this building became a sales center for Model T Fords and was later used by a cab company and automobile body shop and service center. When Kevin Cogan a year ago purchased this property, it was in a state of disrepair. He has transformed it into one of Highlands most unique assets. I think you will enjoy seeing the building at the same time you learn about “One Park’s” redesign. There is no dedicated parking lot but there is on-street parking nearby. This property is located a one block walk from the Castleman Statue.
